



And Assignor does hereby request and authorize the Commissioner of Patents and Trademarks, U.S.A., to issue said **U.S. LETTERS PATENT**, when granted, in accordance with this assignment.

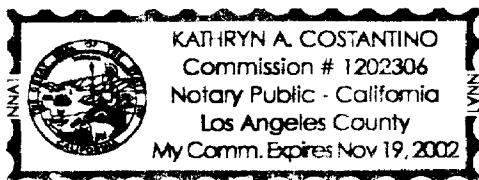
