ASSIGNMENT

WHEREAS, We, JOSE GASTELUM of Verona, New Jersey and LESZEK SOLOWIEJ of Montville, New Jersey, have invented an invention entitled ROBE HOOK which we have made application for Letters Patent of the United States of America; and
