

ASSIGNMENT

And for the above-named considerations, I do hereby agree that I will, at the request of said ASSIGNEE, execute any and all applications for Design Letters Patent for said inventions and any and all other papers and documents and do all other and further lawful acts that said ASSIGNEE may deem necessary or desirable to obtain Design Letters Patent on said inventions, to secure the grant of such Design Letters Patent and to perfect and vest in the ASSIGNEE the entire right, title and interest in the inventions, applications and Design Letters Patent.
