## **ASSIGNMENT**





AND I hereby authorize and request the officials of all countries whose duty it is to issue patents on applications as aforesaid, to issue to the Assignee, as assignee of the entire right, title and interest, any and all Letters Patent for said inventions or improvements,

which may be issued and granted on or as a result of the application aforesaid, in accordance with the terms of this Assignment.
