ASSIGNMENT

WHEREAS, Luigi Scheida, a citizen of Canada whose address is 39 Murray Road, Downsview, Ontario M3K 1T4 (hereinafter called ASSIGNOR) has invented certain new and useful improvements in a BOTTLE for which application for Letters Patent of the United States has been made; and

WHEREAS, Polybottle Group Limited, a Canadian company, whose address is 303 Orenda Road West, Brampton, Ontario L6T 5C3 (hereinafter called ASSIGNEE), is desirous of acquiring all right, title and interest in the United States in and to the aforesaid invention, and in, to and under any and all United States patents to be obtained therefore;

Assignor further agrees without any payment by ASSIGNEE, other than expenses incurred by ASSIGNOR, to communicate to ASSIGNEE, its representatives or agents, facts relating to said invention, including evidence for interference purposes or for other proceedings, whenever requested; to testify in any interference or other proceedings, whenever requested; and to execute and deliver on request all lawful papers required to make any of the foregoing provisions effective, and likewise make these provisions binding upon any legal heirs, legal representatives, administrators and assigns, and ASSIGNOR hereby warrants that, at the time of execution and delivery of this instrument, he is the lawful owner of the entire right, title and interest in and to said invention and said application, and that the same are unencumbered and that he has good and full right and lawful authority to sell and convey the same in the manner herein set forth.
