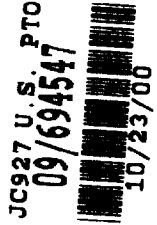


WHEREAS, the undersigned, hereinafter referred to as Assignor, has invented


