ASSIGNMENT AND AGREEMENT



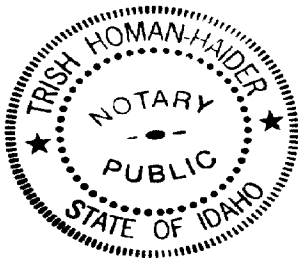


