

ASSIGNMENT

(OK110-CIP)

WHEREAS, We, Edward Bazayev, Edward Scirbona, and Sergey Baykov, hereinafter referred to as ASSIGNORS citizens of the United States, residing at 119-20 Union Turnpike-#E4B2, Kew Garden, New York 11415; 36 Lilac Lane, Danbury, Connecticut; and 84-06 109th St., Apt. 4F, Richmond Hill, New York 11418, respectively, have invented certain new and useful improvements in

WIRE-WRAP/UNWRAP HAND TOOL for which we have executed on this day an application for Letters Patent of the United States; and

WHEREAS, OK International Inc., a Delaware Corporation, having a place of business at 4 Executive Plaza, Yonkers, New York, 10701,

hereinafter referred to as ASSIGNEE is desirous of obtaining the entire right, title, and interest in, to and under the said improvements of the said application;

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) to us in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, we the said ASSIGNORS have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, our entire right, title, and interest in, to and under the said improvements, and the said application and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and we hereby authorize and request the Commissioner of Patents and Trademarks of the United States, any Official of any country of countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY covenant that we have full right to convey our entire interest herein assigned, and that we have not executed, and will not execute any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that we will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
