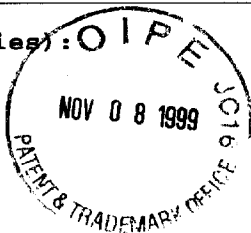

LIGHTING FIXTURE


for which application is being made for Letters Patent, said application being identified by Application No. 29/098,692, filed January 4, 1999, Attorney Docket No. 1302JB-30972.
