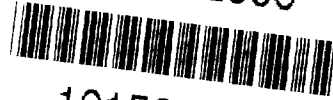

# ASSIGNMENT




