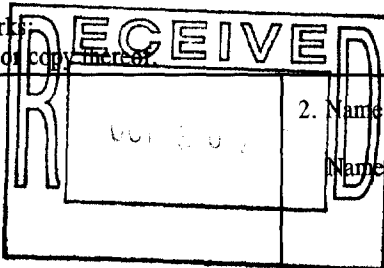

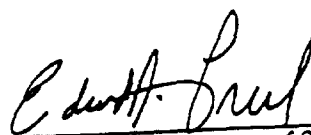

FIRST: The Certificate of Incorporation of the Corporation was originally filed in the Office of the Secretary of State of Delaware on July 11, 2000, and a certified copy was recorded in the Office of the Recorder of Kent County, Delaware.

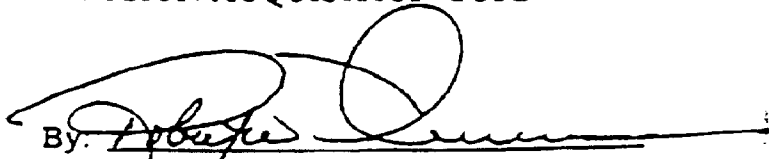
