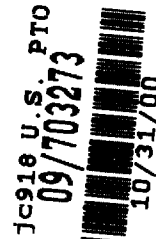

Forrest** of Dundee, United Kingdom (hereinafter called "the inventor(s)"), have invented certain new and useful improvements in **SELF-SERVICE TERMINAL**, Docket No. **8412.00** (hereinafter called "the invention"), for which I have executed an application for Letters Patent of the United States of America (hereinafter called "the application") on 10/24/2000; and

WHEREAS, NCR Financial Solutions Group Limited and NCR Corporation have authorized and requested my/our executing the application; and

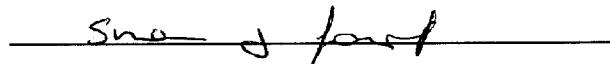

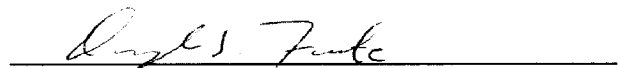

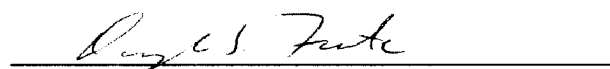
