ASSIGNMENT



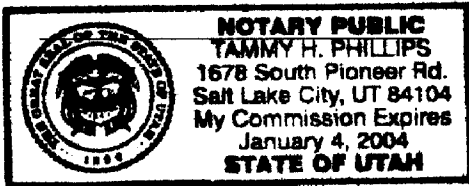
