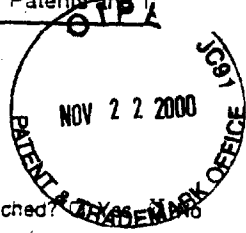

WHEREAS we, Joan Vermeersch, Marc Van Damme and Dirk Kokkelenberg, respectively have made a certain new and useful invention as set forth in an application for United States Letters Patent executed by us the 27th day of November 1998 for "A heat sensitive element and a method for producing lithographic plates therewith" filed on January 22, 1999 under Serial No. 09/235,393, the hereinafter named assignee being hereby authorized to insert the said serial number and filing date when ascertained;

And we request the Commissioner of Patents to issue any Letters Patent of the United States which may be issued for said inventions to said AGFA-GEVAERT its legal representatives, successors or assigns as the sole owner of the entire right, title and interest in and to said patent and in the United States in and to the invention covered thereby.
