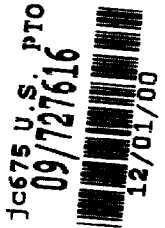

ASSIGNMENT

WHEREAS, We, **Kirk D. Doane, Bryan J. Gettel, Ronald B. Kuenzli, Peter P. Kuperus, Edwyn R. Maschke and Edward J. Talaski**, have invented certain improvements in a **FUEL SUPPLY SYSTEM RESPONSIVE TO ENGINE FUEL DEMAND**, for which we are about to make application for Letters Patent of the United States of America; and
