ASSIGNMENT

WHEREAS, I, Eric Daniel Jean Philippe Spampinato, of 4, Le Champ Fleuri, 35630 Langouët France, have made new and useful improvements in FREQUENCY SYNTHESIS DEVICE; for which application for Letters Patent of the United States has been filed on September 13, 2000 under Serial No. 09/661,256; and
