WHEREAS, James Xixian Wu, residing at 23768 Curtis Drive, North Olmsted, Ohio 44070, respectively (hereinafter referred to as Assignor), has invented certain new and useful improvements in ALKALINE ELECTROCHEMICAL CELL HAVING ADHESIVE CLOSURE for which an application for United States Letters Patent was executed on even date herewith.
