THE PATENT ASSIGNMENT

ASSIGNMENT

WHEREAS, we, **Michael J. Voznick** and **Sandra Henson**, both citizens of the United States, at 2158 Cumberland Parkway, Atlanta, Georgia 30339 (hereinafter collectively referred to as "ASSIGNOR"), have invented a **decorative cap that can be placed on the roof of a vehicle**, for which an application for letters patent was filed August 17, 1995 bearing application serial number 08/516,338 (the "Invention"); and

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to us in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, said ASSIGNOR hereby sells, assigns, and transfers and sets over, unto said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under said Invention, all Patents of the United States which may be granted thereon and all reissues, reexaminations and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States application under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models and designs which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals, reexaminations and reissues thereof;

ASSIGNOR HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

ASSIGNOR HEREBY grants the firm of DINSMORE & SHOHL LLP the power to insert in this Assignment any further identification or information which may be necessary or desirable in




