ASSIGNMENT

WHEREAS, WE, DANIEL J. BELNAP, NATHAN R. ANDERSON, ZHIGANG FANG, ANTHONY GRIFFO, BRIAN A. 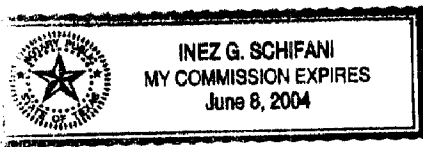

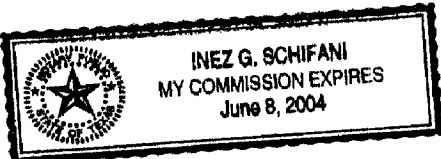

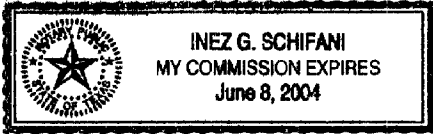
