INVENTION AND LETTERS PATENT ASSIGNMENT

INVENTION AND LETTERS PATENT ASSIGNMENT AGREEMENT (this "**Agreement**") made this 28th day of October, 2000, by Uhlich Color Company, Inc., a New York corporation, with offices located at 5620 North Kolb Road, Tuscon, Arizona 85750 ("**Uhlich**") in favor of Magruder Dry Color, LLC, a New Jersey limited liability company, with offices located at 1029 Newark Avenue, Elizabeth, New Jersey 07208-3518 ("**Magruder**").

RECITALS

WHEREAS, Sain D. Kapoor ("**Kapoor**") is the inventor of an invention entitled "Crystal Growth Inhibitor" (the "**Invention**") and the applicant with respect to the Application for Letters Patent of the United States, which was filed on November 4, 1998 as U.S. Application No 09/185,931;

WHEREAS, pursuant to that certain Assignment dated March 19 1999, Kapoor assigned all of his right, title, and interest in and to the Invention to Uhlich;

WHEREAS, Uhlich is the owner of the Letters Patent (Registration #) with respect to the Invention (the "**Letters Patent**")

WHEREAS, Uhlich is a party to that certain Asset Purchase Agreement by and among Uhlich, Michael DeMaio, Abdul Saleh, Kapoor, and Magruder (the "**Purchase Agreement**"); and

WHEREAS, in connection with the transactions contemplated by the Purchase Agreement, Magruder is desirous of acquiring from Uhlich all of its rights to the Invention and its rights to the Letters Patent, upon the terms and subject to the conditions hereinafter set forth:

NOW, THEREFORE, for good and valuable consideration in the amount of \$10 and other consideration set forth in the Purchase Agreement, receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignment. Uhlich does hereby assign and transfer to Magruder and the successors, assigns, and legal representatives of Magruder (i) its entire right, title, and interest in and to the Invention for the United States and its territorial possessions and in all foreign countries, including all rights to claim priority, in and to any and all improvements which are disclosed in the Invention and (ii) its entire right, title, and interest in and to the Letters Patent or any continuation, division, renewal, or substitution thereof, and as to the Letters Patent any re-issue or re-examination thereof.

2. Further Assurances. Uhlich agrees to perform all reasonable and proper acts at the request and expense of Magruder which Magruder may require in order to vest all of Magruder's right, title, and interest in and to the Invention and the Letters Patent in Magruder or its successors, assigns, and legal representatives.

3. General. This Agreement: (a) contains the entire agreement and understanding of the parties with respect to the subject matter hereof; (b) shall be binding on the parties and their respective successors, assigns, and representatives; (c) shall be governed by and construed in accordance with the laws of the State of New Jersey; and (d) can only be modified by a writing signed by the parties hereto.
