ASSIGNMENT

WHEREAS, Robert J. Langeland, residing at 2530 Argus S.E., Grand Rapids, Michigan 49546, respectively (hereinafter referred to as Assignor), has invented certain new and useful improvements in ADHESIVE FORMULATION for which an application for United States Letters Patent was executed on even date herewith.
