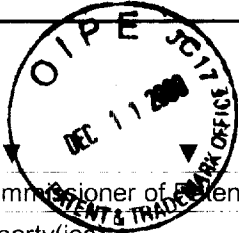

ASSIGNMENT

WHEREAS, we, **SUAT GENC, LARRY A. PITTS, KEVIN L. MEASE, CHARLES M. CARLSTROM AND RUSSEL H. MARVIN**, are joint inventors of "**VOLTAGE MONITORING SYSTEM FOR A FUEL CELL STACK**" application for United States Letters Patent Serial No. 09/629,548 July 31, 2000




