**ASSIGNMENT OF UNITED STATES PATENTS  
AND PENDING PATENT APPLICATIONS**

**WITNESSETH**

WHEREAS, the following persons and legal entities each have, or may have, an interest of some kind in any or all of the United States patents and pending patent applications identified in "Exhibit A" attached hereto and incorporated by reference as part of this instrument of assignment (hereinafter referred to collectively as the "PATENTS" and "APPLICATIONS," respectively): (i) Adrian Gluck, an individual; (ii) Adrian Gluck & Associates, Inc., a California corporation; (iii) LaserVision Technologies, Inc., a California corporation (formerly known as LaserVision Productions, Inc.); (iv) LaserVision Technologies International, Ltd., a Bahamian corporation (formerly known as LaserVision Productions International, Ltd.); and (v) L.N.C.J., Limited (also known as LNCJ, Ltd.), a Channel Islands entity (hereafter referred to collectively as "ASSIGNORS"); and

WHEREAS, Adrian Gluck is an officer, director, shareholder, grantor, general partner, agent, principal and/or trustee, in at least one capacity or the other, of each of the above-identified non-individual ASSIGNORS; and

WHEREAS, Adrian Gluck has been in control of and/or had the power, inter alia, to conduct the business of each of the ASSIGNORS (including, without limitation, the power to transfer property, including, without limitation, intellectual property in which the ASSIGNORS, or any of them, have any rights, titles or interests); and

WHEREAS, on or about February 27, 1998, a judgment was entered in favor of Stephen E. Turner, an individual residing in Newport Beach, California (and whose address is c/o Law Offices of Barry B. Kaufman, APC, 16133 Ventura Blvd., Suite 700, Encino, California 91436 (hereafter, "ASSIGNEE") by the Superior Court for the State of California in and for the County of Orange (hereafter, the "Court") against

LaserVision Technologies, Inc. (formerly known as LaserVision Productions, Inc.) and LaserVision Technologies International, Ltd. (formerly known as LaserVision Productions International, Ltd.) (hereafter, the "LaserVision Defendants") in the civil case filed and prosecuted by ASSIGNEE entitled *Stephen E. Turner v. Laservision Productions, Inc., et.al.* (Case No. CIV 75-04-67) (hereafter, the "Civil Action"); and

WHEREAS, by virtue of having obtained said Judgment in the Civil Action, ASSIGNEE is a judgment-creditor of the LaserVision Defendants in the Civil Action (said defendants comprising some, but not necessarily all, of the ASSIGNORS); and

WHEREAS, those ASSIGNORS not specifically named as defendants in the Civil Action are all closely related to the LaserVision Defendants and, by virtue of transfers and conveyances made by the LaserVision Defendants with knowledge of the Civil Action after the commencement thereof, have acquired or been transferred certain rights, titles or interests in the PATENTS and/or APPLICATIONS; and

WHEREAS, ASSIGNEE, as judgment creditor, previously obtained an Order from the Court on November 24, 1998 compelling the LaserVision Defendants and related parties then in possession of their PATENTS and APPLICATIONS to "immediately turn over [said] property" (and other property) to ASSIGNEE (hereafter, the "TURNOVER ORDER"); and

WHEREAS, despite personal service of the TURNOVER ORDER on Adrian Gluck, no transfer/conveyance of any right, title or interest of any kind whatsoever in any or all of the PATENTS and/or APPLICATIONS was made or effected; and

WHEREAS, on February 23, 2001, ASSIGNEE, as judgment creditor, filed an ex parte application with the Court for an Order amending the TURNOVER ORDER to require the assignment to ASSIGNEE of any and all of the rights, titles and interests in any or all of the PATENTS and/or APPLICATIONS which ASSIGNORS, or any of them, have or may have; and

WHEREAS, on February 28, 2001, the Court, after reviewing said ex parte application and entertaining brief argument by counsel for ASSIGNEE, (a) found that the prior acts and omissions of Adrian Gluck and others of the ASSIGNORS indicates that said persons will not (and would not) execute an assignment of the PATENTS and APPLICATIONS *even if* the Court directed said persons to execute an assignment; (b) found that there was good cause and need for the requested order; and (c) entered an Order assigning and conveying to ASSIGNEE all of ASSIGNORS' respective rights, titles and interests of any kind whatsoever in any or all of the PATENTS and/or APPLICATIONS which they, or any of them, have or may have in the future;

WHEREAS, also on February 28, 2001, the Court further ordered that the Sheriff/Marshall of the County of Orange shall execute any and all documents necessary to effectuate the assignment and conveyance of ASSIGNORS' respective rights, titles and interests in the PATENTS and/or APPLICATIONS to ASSIGNEE;

NOW, THEREFORE, pursuant to said Order of the Court, the Sheriff/ Marshall of the County of Orange has executed this Assignment instrument for and on behalf of ASSIGNORS to perfect the assignment and transfer of all right, title and interest in the PATENTS and APPLICATIONS to ASSIGNEE for the purpose of transferring, conveying and assigning unto ASSIGNEE all rights, titles and interest in and to: (A) the PATENTS (and the inventions disclosed and claimed therein, and any reissued applications pertaining thereto, and any reissued PATENTS granted on such reissued applications, and any re-examinations of the PATENTS or reissues thereof); (B) the APPLICATIONS (and the invention disclosed and claimed therein, and any continuations, continuations-in part and/or any divisional applications thereof (said applications to be included within the meaning of the term APPLICATIONS as used herein); and (C) any patents which may be granted on the APPLICATIONS, or any of them ("Future Patents") (and any reissue applications pertaining to any of the Future Patents, and any reissued Future Patents granted on such reissue applications, and any re-examinations of any of the Future Patents or reissues thereof), all of which are to be held and enjoyed by ASSIGNEE for his own use and enjoyment and for the use and enjoyment of his heirs, successors, assigns, and

legal representatives, to the end of the terms for which the PATENTS, APPLICATIONS and Future Patents are or may hereinafter be granted or reissued.


