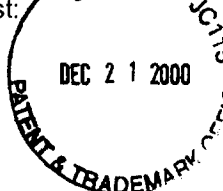

## ASSIGNMENT

WHEREAS, Han Li, Toshio Miki and Yasuhiro Ogiri, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled, Method and Apparatus for Transcoding Coded Video Image Data, executed by Assignors on the same date as this Assignment;
