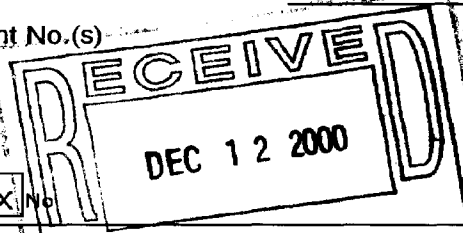

PATENT ASSIGNMENT

THIS ASSIGNMENT is made effective as of the 1st day of January 2000, by Robert Bosch Technology Corporation, a Michigan Corporation, ("RBTC"), in favor of Robert Bosch Corporation, a Delaware Corporation, ("Bosch").

WITNESSETH:

WHEREAS, RBTC is the owner of the right, title and interest in and to the invention identified in Robert Bosch Braking Systems Disclosure No. 99/7505-6 (R.75310) and covered by U.S. Patent Application No. 09/365,577 filed August 2, 1999, hereinafter referred to as the "Patent Application".

WHEREAS, Bosch is desirous of acquiring the entire right, title and interest in and to the Patent Application.

WHEREAS, RBTC agrees to assign its interest in and to the Patent Application to Bosch.

NOW THEREFOR, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, RBTC does hereby sell, assign and transfer to Bosch all of its right, title and interest in and to the Patent Application. RBCT does further hereby sell, assign and transfer and set over unto Bosch, its successors and assigns, all claims, demands and rights of actions that it has or might have by reason of infringements of any patent(s) which may issue from the Patent Application, together with the right, at its expense, to prosecute and collect such claims, demands and rights of action, if necessary, in the name of RBTC.
