BACKGROUND OF THIS ASSIGNMENT:

ASSIGNOR is the owner of certain new and useful inventions disclosed in United States Patent Application Serial No. 105,349 titled Plastic Container Sorting System and Method, now Patent No. 5,443,164, issued August 22, 1995.
