Licence Agreement

THIS AGREEMENT made the *thirtieth* day of *October* 2000

BETWEEN THE SECRETARY OF STATE FOR DEFENCE acting through the Defence Evaluation and Research Agency, Farnborough, Hampshire GU14 0LX (hereinafter called "DERA") of the one part, and

20/20 SPEECH LIMITED, whose registered office is 37 Ixworth Place, London SW3 3QH (hereinafter called ("TTSL")), of the other part.

WITNESSETH that DERA hereby grants unto the Licensee an exclusive licence within the field of applications of speech recognition under United States Patent Number US 5974385 (hereinafter called "the Licence") upon the terms and conditions of an Agreement dated the 29th day of November 1999 and made between the parties hereto; TTSL shall have the right to grant sub-licences under the Licence but the Licence shall not be assigned mortgaged or charged without the prior written consent of DERA.
