# ASSIGNMENT OF UNITED STATES PATENT RIGHTS

ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States to issue the PATENT RIGHTS to ASSIGNEE in accordance with the terms of this instrument.
