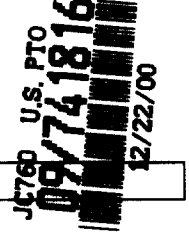

Schroeder, being a citizen of the U.S.A., and residing at 1041 High Street, Dedham, MA 02026; Sang William Tam, being a citizen of the U.S.A., and residing at 148 Pine Street, Dover, MA 02030; am the inventor of certain new and useful inventions and discoveries, for which application(s) for Letters Patent entitled "NITROSATED AND NITROSYLATED CYCLOOXYGENASE-2 INHIBITORS, COMPOSITIONS AND METHODS OF USE " which are being filed herewith with the United States Patent and Trademark Office herewith, and with the United States Patent and Trademark Office as Receiving Office for the Patent Cooperative Treaty;
