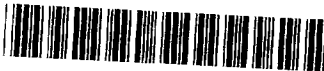

or by treaty or by international convention, together with the right to extend the protection of said United States Letters Patent to territorial possessions now owned or which may hereafter be acquired by the United States of America, for the full term of which said Letters Patent or said other forms of protection may be granted;

And I covenant and agree with **ASSIGNEE** that I have full and unencumbered title to the invention hereby assigned, which title I warrant to **ASSIGNEE**;




