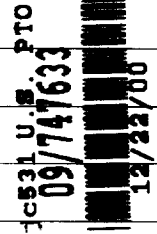

## ASSIGNMENT

WHEREAS, WE, Robert G. Conner, a citizen of the United States, residing at 7116 Lower Vally Pike, New Carlisle, Ohio 45344, County of Clark, and State of Ohio; and Chris W. Snyder, a citizen of the United States, residing at 6062 Hartzell Road, Greenville, Ohio 45331, County of Darke, and State of Ohio; (hereinafter referred to as "ASSIGNORS"), have invented a METHOD AND APPARATUS FOR PROVIDING A LASER DETECTOR CLAMP APPARATUS WITH REVERSIBLE JAW ADAPTER, for which we have executed an application for Letters Patent of the United States, of even date herewith, and

WHEREAS, Apache Technologies, Inc., a corporation duly organized and existing under the laws of Ohio, having its principal place of business at 7415 Chambersburg Road, Dayton, Ohio 45424-3921 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring the entire interest therein:

ASSIGNORS HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

ASSIGNORS HEREBY grant the firm of Davidson & Gribbell, LLP the power to insert in this Assignment any further identification or information which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.

ASSIGNORS HEREBY covenant and agree that they have full right to convey the entire interest herein assigned, and that they have not executed, and will not execute, any agreement in conflict herewith.

ASSIGNORS HEREBY further covenant and agree that they will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to them respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue, reexamination and foreign applications, make all rightful oaths, and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said invention in all countries.

ASSIGNORS HEREBY further agree to execute all necessary and lawful future documents, including assignments in favor of Assignee, or its designees as Assignee or its Assignees may from time-to-time present to them in order to perfect title in said Invention, modifications, and improvements in said Invention, applications and Letters Patent of the United States and countries foreign thereto;
