

ASSIGNMENT

WHEREAS, the undersigned, Larry P. Hobbs, a resident of the City of Brentwood, County of Contra Costa, State of California and Pradeep Bhardwaj, a resident of the City of Livermore, County of Alameda, State of California; (hereinafter termed "Inventors"), have invented certain new and useful improvements in ***INERTIAL RATE SENSOR AND METHOD WITH BUILT-IN TESTING***, and have executed an application for a United States patent disclosing and identifying the invention; and having Serial No. 09/663,740 and filing date of September 15, 2000; and

WHEREAS, BEI Technologies, Inc., (hereinafter termed "Assignee"), a corporation of the State of Delaware, having a place of business at One Post Street, Suite 2500, San Francisco, State of California, is desirous of acquiring the entire right, title and interest in and to said application and the invention disclosed therein, and in and to all embodiments of the invention, heretofore conceived, made or discovered by said Inventors (all collectively hereinafter termed "said invention"), and in and to any and all patents, inventors' certificates and other forms of protection (hereinafter termed "patents") thereon granted in the United States and foreign countries.

1. 2. Said Inventors hereby covenant and agree to cooperate with said Assignee to enable said Assignee to enjoy to the fullest extent the right title and interest herein conveyed in the United States and foreign countries. Such cooperation by said Inventors shall include prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance all to the extent deemed necessary or desirable by said Assignee (a) for perfecting in said Assignee the right, title and interest herein conveyed; (b) for prosecuting any of said applications; (c) for filing and prosecuting substitute, divisional, continuing or additional applications covering said invention; (d) for filing and prosecuting applications for reissuance of any said patents; (e) for interference or other priority proceedings involving said invention; and (f) for legal proceedings involving said invention and any applications therefor and any patents

granted thereon, including without limitation opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions; provided, however, that the expense incurred by said Inventors in providing such cooperation shall be paid for by said Assignee.

3. The terms, covenants and conditions of this assignment shall inure to the benefit of said Assignee, its successors, assigns and other legal representatives, and shall be binding upon said Inventors, their heirs, legal representatives and assigns.

4. Said Inventors hereby warrant and represent that they have not entered and will not enter into any assignment, contract, or understanding in conflict herewith.
