## ASSIGNMENT OF UNITED STATES PATENT APPLICATION

NOW, THEREFORE, to all whom it may concern be it known that we, the inventor(s), confirm the ownership by NCR Financial Solutions Group Limited of the invention and the application by operation of law under the United Kingdom Patents Act 1977 and if, under the law of the United States, or any other countries in the world, we the inventor(s) have any ownership right, title, and interest in the invention and the application (which we do not believe to be the case and claim no ownership right, title, or interest in the invention and the application based on the law of the United Kingdom), in consideration of the sum of One Dollar (\$1.00) and of other valuable considerations, the receipt of which is hereby acknowledged, we, the inventor(s), nevertheless hereby assign and transfer such ownership right, title, and interest in and to the invention and application to NCR Financial Solutions Group Limited, its successors and assigns.




