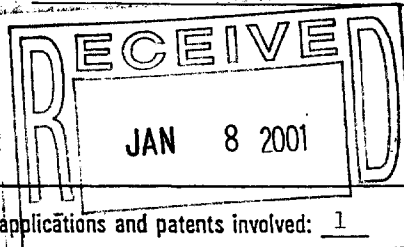


ASSIGNMENT





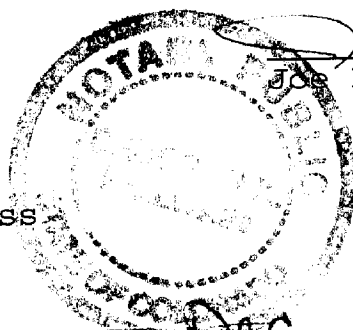
