

and the ASSIGNOR further represents and warrants that he hereby binds himself and his heirs, executors, administrators and legal representatives to communicate at any time, upon request to the ASSIGNEE, his heirs and legal representatives any facts relating to the invention and the history thereof known to him or to his heirs, executors, administrators and legal representatives, and that he will testify as to the same in any interference to obtain or any other litigation to enforce the patent or patents which may be granted for said invention when requested to do so by the ASSIGNEE, his heirs or legal representatives.

The ASSIGNOR hereby authorizes and requests the COMMISSIONER OF PATENTS AND TRADEMARKS to issue Letters Patent which may be granted for said invention to the ASSIGNEE as the assignee of said part interest therein.
