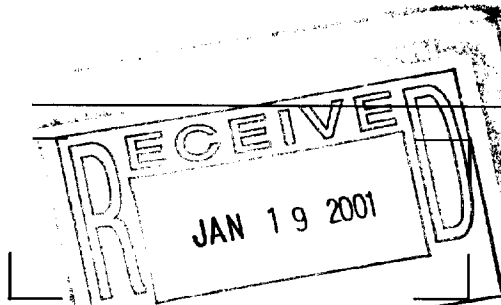

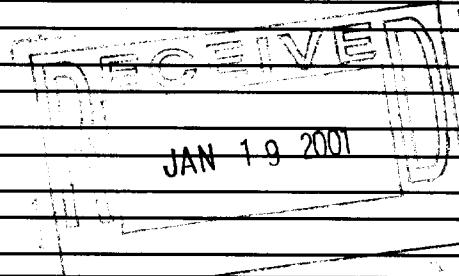

PATENT ASSIGNMENT

WHEREAS, JOHN M. FITTS ("MR. FITTS") is the named inventor in United States Patent No. 5,319,445;

WHEREAS, MR. FITTS and DORIS C. FITTS, his wife, created the Fitts Family Revocable Trust by a certain Trust Agreement dated December 10, 1991;

WHEREAS, MR. FITTS executed his Last Will and Testament on December 10, 1991;

WHEREAS, MR. FITTS died on April 6, 1998;

WHEREAS, the title to U.S. Patent No. 5,319,445 has never been explicitly assigned or transferred to anyone;

WHEREAS, the title to said U.S. Patent No. 5,319,445 was not part of the assets of said trust at the time of MR. FITTS death;

WHEREAS the Pour-Over clause (paragraph SECOND) of MR. FITTS' December 10, 1991 Will transferred the title to said U.S. Patent No. 5,319,445 from MR. FITTS' estate to the Fitts Family Revocable Trust; and

WHEREAS it appears that title to U.S. Patent No. 5,319,445 should have been transferred to Electro-Optical Information Systems, Inc. before MR. FITTS' death, but MR. FITTS' lengthy illness made the formalities impossible for such transfer.

NOW THEREFORE, for \$10 and other good, valuable and legally sufficient consideration, receipt of which is hereby acknowledged,

1. Effective January 6, 1997, The Fitts Family Revocable Trust, by DORIS C. FITTS, acting as trustee and not individually, ("the Assignor") does hereby sell, convey, assign and transfer to Electro-Optical Information Systems,

Inc., a California corporation, ("the Assignee") whose mailing address is 1221 Broadway, Suite 204, City of Santa Monica, and the State of California, the entire right title and interest in and to U.S. Patent No. 5,319,445, including the full right to sue for past, present or future infringement of said patent, and the right to have and to hold said patent for the sole and exclusive use and benefit of said Assignee, its successors and assigns, to the full extent of the term of said patent, and to stand in place of said Assignor in all matters relating to said patent.

2. The Assignor does hereby covenant and agree that it will execute and deliver to the said Assignee any and all additional papers which may be requested by the said Assignee to fully carry out the terms of this Assignment and to record this Assignment with the United States Patent Office.

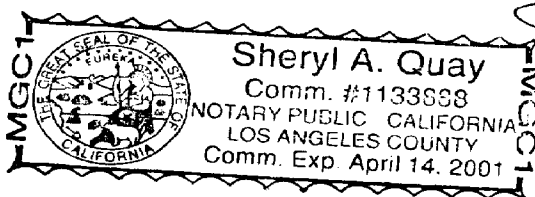
