ASSIGNMENT



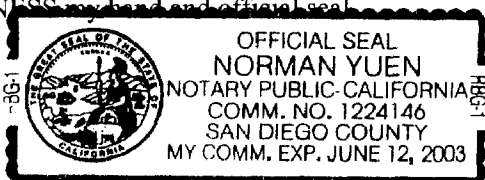

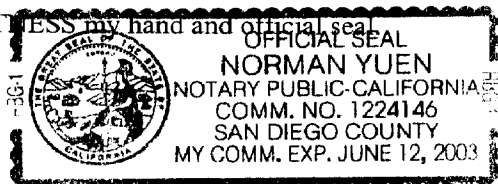
