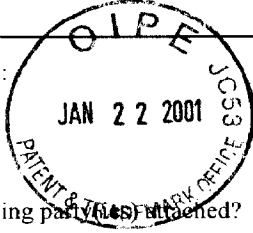

IN WITNESS WHEREOF, the ASSIGNOR has caused this Assignment to be executed by its duly authorized representative as of April 11th, 2000.


