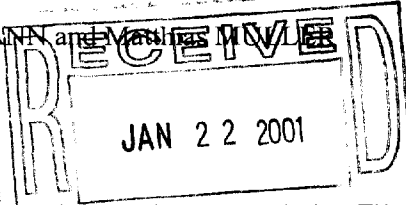

### HOUSING FOR RECEIVING ELECTRICAL AND/OR ELECTRONIC BUILT-INS
