

ASSIGNOR covenants that no assignment, grant, mortgage, license, or other agreement affecting the rights and property herein conveyed has been made to others by **ASSIGNOR**, and that full right to convey the same as herein expressed is possessed by **ASSIGNOR**.

This agreement constitutes the entire agreement of the parties and supersedes and cancels

any and all prior and/or contemporaneous utterances, statements, representation, understandings and/or agreements whether oral and/or written in connection with this agreement.


