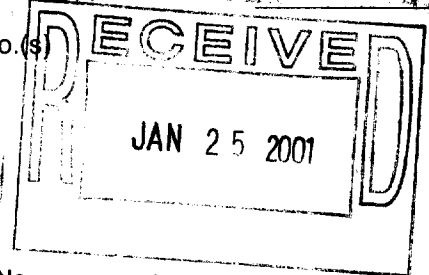

PATENT ASSIGNMENT





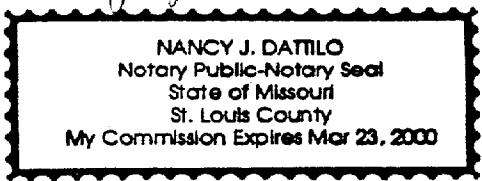
