consideration Assignor hereby covenants and agrees that it will, when ever counsel for Assignee, or counsel for its legal successors, legal representatives, heirs or assigns shall advise that any proceedings in connection with said Patent Properties or reissues or extensions of said Letters Patent to be obtained thereon, is lawful and desirable, sign all papers and documents, make all lawful oaths, and do all acts necessary as required to be done for the procurement, maintenance, enforcement and defense of said Patent Properties without charge to said Assignors, its successors, legal representatives, heirs and assigns, but at the expense of said Assignee, its successors, legal representatives, heirs and assigns.




