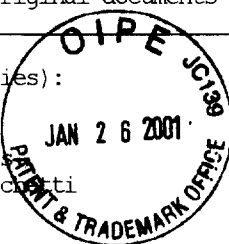

# ASSIGNMENT




