
We further covenant that we have the lawful right to assign the interest in said improvements in the manner and form as herein expressed, that the interests herein

conveyed are free from prior assignment, grant, mortgage, license, or other encumbrance whatsoever and that the execution of this Assignment is our own free act and deed.




