ASSIGNMENT

WHEREAS, We, Alastair Hodges, an Australian citizen, residing at 11752 Westview Parkway, Apt. 6, San Diego, CA 92126; and Ronald Chatelier, residing at 11816 Westview Parkway, Apt. 174, San Diego, CA 92126, have invented certain new and useful improvements in a **SENSOR WITH IMPROVED SHELF LIFE** for which we have filed an application for Letters Patent in the United States, Application No. 09/664,668; Filed: September 19, 2000;

AND WHEREAS, USF FILTRATION AND SEPARATIONS GROUP, INC. AND WE HEREBY covenant and agree that we will communicate to the said ASSIGNEE, his successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, his successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.

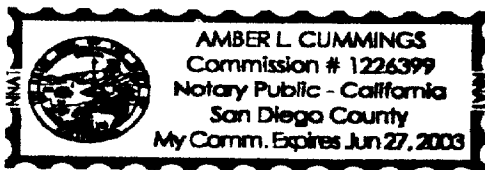

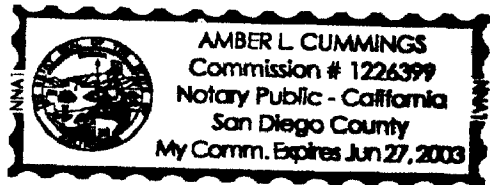
