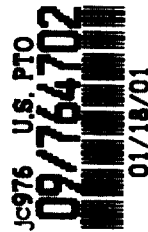

Whereas We, Yair Egozy, whose residence address is 39 Grapeshot Road, Sharon, MA 02067, Paul J. Vernucci, whose residence address is 7 Dyer Street, Billerica, MA 01821, Leslie E. 


