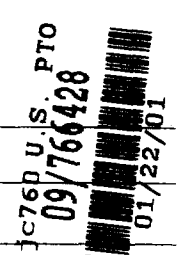

## ASSIGNMENT

WHEREAS, WE, David C. Sudolcan and Thomas J. Chadwell, citizens of the United States, residing at 12365 Rudolph Rd, #1, Atascosa, Texas 78002 and 3539 Oakhorne, San Antonio, Texas 78247, respectively, (hereinafter referred to as "Assignors") have invented certain new and useful improvements in AN ELECTRONIC CONTROL SYSTEM FOR A BEVERAGE DISPENSER, for which we have executed an application for Letters Patent of the United States, of even date herewith; and

Assignors further assign to Assignee, its successors, assigns or other legal representatives, any and all claims for damages by reason of past and continuing infringement of said patents, and the right to sue for and collect the same for its own use and benefit and that of its successors, assigns or other legal representatives.

WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

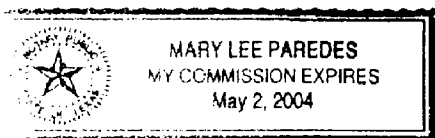

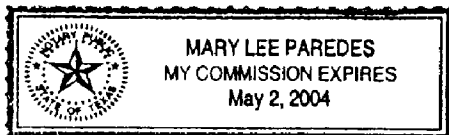
