WHEREAS, Toshio NAKAGISHI, a citizen of Japan, whose post office address is c/o ASAHI KOGAKU KOGYO KABUSHIKI KAISHA, 36-9, Maenochō 2-chōme, Itabashi-ku, Tokyo, Japan; Koji SATO, a citizen of Japan, whose post office address is c/o ASAHI KOGAKU KOGYO KABUSHIKI KAISHA, 36-9, Maenochō 2-chōme, Itabashi-ku, Tokyo, Japan; and Isao OKUDA, a citizen of Japan, whose post office address is c/o ASAHI KOGAKU KOGYO KABUSHIKI KAISHA, 36-9, Maenochō 2-chōme, Itabashi-ku, Tokyo, Japan: hereinafter referred to as the ASSIGNORS, have invented a certain improvement relating to Structure for mounting a solid-state imaging device for which they have, on the respective dates indicated below, jointly executed an application for Letters Patent for the United States to be filed in the United States Patent and Trademark Office.

arising from or pertaining thereto, for and during the term or terms of any and all such Letters Patent when granted, including any and all renewals, reissues, and prolongations thereof, for the use and benefit of said ASSIGNEE and its assigns and legal representatives in as ample and beneficial a manner to all intents and purposes as the said ASSIGNORS might or could have held and enjoyed the same, if this assignment had not been made.

AND said ASSIGNORS hereby agree to execute all papers necessary to file applications in the United States for said invention and to assign the same to said ASSIGNEE, or any ASSIGNEE acquiring title to said invention, and to execute any other papers that may be needed in connection with filing said application and securing Letters Patent thereon.

AND said ASSIGNORS authorize and request the Commissioner of Patents to issue Letters Patent on said application, and on any and all divisions and continuations thereof, to said ASSIGNEE, its assigns and legal representatives, in accordance herewith.
