PATENT ASSIGNMENT

For One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, FONIX CORPORATION, a Delaware corporation having a principal place of business at 1225 Eagle Gate Tower, 60 East South Temple Street, Salt Lake City, Utah 84111 (the "Assignor"), hereby sells, assigns and transfers to LERNOUT & HAUSPIE SPEECH PRODUCTS N.V., a Belgian corporation having a place of business at Flanders Language Valley 50, B-8900 Ieper, Belgium, and its successors and assigns (the "Assignee"), the entire right, title and interest in and to all of the patents and patent applications and any continuations thereof owned by Fonix/ASI Corporation ("ASI") immediately prior to the merger of ASI with and into Assignor (the "Merger"), effective as of the date hereof, and now owned by Assignor as a result of the Merger, including, but not limited to, those patents and patent applications and any continuations thereof set forth on Exhibit A attached hereto, together with all rights represented by such patents and patent applications, including, without limitation, any invention disclosures, including any patents issuing therefrom, and any reissues, reexaminations, divisions, continuations in whole or part, extensions and foreign counterparts thereof.

Assignor further assigns to Assignee, its successors, assigns or other legal representatives, any and all claims for damages by reason of any past and continuing infringement of such patents and patent applications and the right to sue for and collect the same for its own use and benefit and that of its successors, assigns or other legal representatives, except as provided in Section 1.2(b)(xi) of the Asset Purchase Agreement, dated as of May 19, 1999, by and among the Assignor, the Assignee and ASI (the "Agreement") and Schedule 1.2(b)(xi) to the Agreement, but including all of ASI's and Assignor's rights, title and interests in and to claims instituted by ASI (and/or its predecessors in interest) against Apple Computer Corporation currently pending in the United States District Court for the District of Massachusetts and the right to collect damages for infringement of such intellectual property rights by Apple Computer Corporation or others incurred while Fonix, ASI and/or Articulate Systems, Inc. owned such rights.

Assignor agrees for itself and its successors, representatives and assigns, without further compensation to perform such lawful acts and to sign such further applications, assignments, preliminary statements and other lawful documents as the Assignee may reasonably request to effectuate fully this Assignment.

This Patent Assignment is subject to the terms and provisions of the Agreement and in the event of a conflict between this Patent Assignment and the Agreement, the terms of the

Agreement (as affected by the Merger) shall control.
