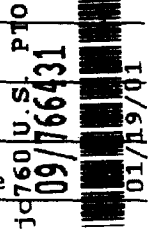

ASSIGNMENT



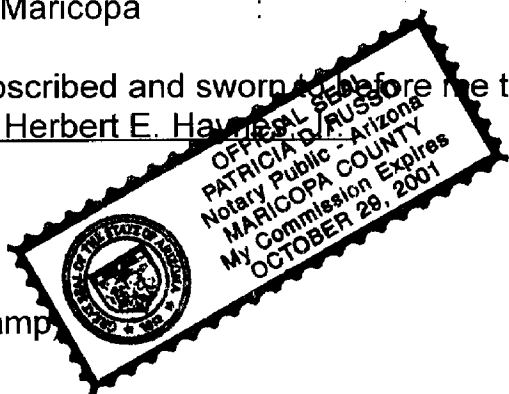


